ASE 572 FEDERAL, STATE, AND LOCAL SCHOOL LAW COURSE SYLLABUS Fall 2007

COURSE DESCRIPTION

The course provides a study of (a) the legal basis of school control, (b) the relation of the federal government to public education, the state as the fundamental legal unit in organization and administration of a state system of schools, (c) the district as the unit of local school control, and (d) legal duties and responsibilities of the state and local boards of education. This course is designed to develop and improve the students' knowledge and understanding of the basic legal parameters that impact organization and control of the Texas and American public schools.

COURSE REQUIREMENTS

- ➤ Legal Brief *Due October 3* (10 points)
 Prepare two written legal briefs (format provided) from cases in the required text.
 Briefs shall be no more than two pages.
- ➤ Chapter Presentation (30 points)

 Each student will lead the class in a weekly discussion from assigned chapters in the required text. The presentation will include a chapter outline or notes. All other students will support the presenter by orally summarizing one or more cases from the chapter.
- ➤ Internship Activities *Due November 7* (30 points)
 As required, internship activities must be completed and evaluated as part of the course grade. Write a one-page summary of each of the Internship Activities for ASE 572.
- Final Examination *Due November 28* (30 points)

INTERNSHIP ACTIVITIES FOR ASE 572

- ➤ Describe your principal's interpretations of three legal actions that were taken within the past three years.
- > Describe how your principal ensures that the school follows the Code of Ethics and Standard Practices for Texas Educators.
- ➤ Describe the school secretary's role in office management, including procedures for securing correspondence, student discipline records, and personnel records.
- Describe changes to the campus discipline management process due to current law.
- Describe the principal's responsibility for monitoring the safety and welfare of the school community.

EXPECTATIONS

- 1. Graduate students are governed by the Sam Houston State University student code of conduct.
