This course identifies and analyzes contemporary issues in community college curriculum, including transfer, workforce, tech prep, and dual credit. The course is intended to enable the student to develop a comprehensive view of the community college curriculum. By doing so, the student will be more knowledgeable in an area of leadership that is critical to the success of community colleges.
