4. **Course Description:** Topics include coordinate systems, circular functions, solutions of triangles, identities, trigonometric equations, and inverse functions.

Prerequisites: Two years of high school algebra and one year of high school geometry.

The class will be primarily lecture-oriented.

- 5. Course Objectives: You will learn to analyze, logically address, and solve problems using the tools and techniques from trigonometry. Special emphasis will be given to the ideas needed for calculus.
- 6. Required Textbook: Trigonometry by McKeague, Fifth Edition.
- 7. **Required Supplies:** A graphing calculator with the trigonometric functions is required. I have and will be using the TI-84 plus.
- 8. **Attendance Policy:** You are expected to attend every class *and to arrive on time*. If class must be missed, you are expected to get the notes and homework assignment from a classmate.
- 9. Assignments:
  - (a) **Homework:** Homework will be assigned every class period. At least once a week, I will give a quiz based upon the homework, required reading, and lectures. It is your responsibility to ask questions about homework problems which you were not able to complete or did not understand.
  - (b) **Quizzes:** The quizzes will be based on the homework assignments, required reading, and lectures. Each quiz will be given during the first 10-15 minutes of class, and extra time will not be allowed, if you are late to class. *There are no make-up quizzes*, but (at least) your lowest quiz score for the semester will be dropped.
- 10. **Exams:** There will be three exams during the semester and then a final exam. The exams are scheduled to occur on:
