COURSE OBJECTIVES:

The primary objectives of this course are to survey state-of-the-art metal cutting and joining processes and materials that are currently utilized in the industry. The opportunity for the development of understanding and skills in gas tungsten arc welding (GTAW), gas metal arc welding (GMAW), shielded metal arc welding (SMAW), and plasma arc and oxy-fuel cutting and welding processes will be provided. In addition welding metallurgy hardfacing, and destructive and non-destructive weld testing will be covered.

COURSE FORMAT:

This course is a combination of lecture, demonstrations, student presentations, and supervised practice.

COURSE ASSIGNMENTS:

Each class member will be responsible for identifying a modern or emerging metallic cutting, welding, or surfacing process. The student is to research the development of the process and the current status, the materials, equipment, procedures and recommended applications amd develop a research paper. Advanced approval of the topic area is required and will be granted on a first-come first-served basis. Information is to be written up in approved research paper format. Report is to be typed or computer generated. Paper should be a minimum of ten pages excluding any pictures, charts, graphs, references and bibliography.

Each class member will be responsible to give a class presentation over their research paper complete with a demonstration of the application or process if feasable. The presentation should be presented as if it was given to advanced high school, adult education, or on-job continuing education training class.

DEPARTMENT OF AGRICULTURAL SCIENCES ATTENDANCE POLICY:

- 1. Regular and punctual attendance is expected of each student in the Department of Agricultural Sciences at Sam Houston State University.

ACADEMIC DISHONESTY:

DISRUPTIVE CONDUCT:

Students will refrain from behavior in the classroom or lab that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers **must be turned off before** class begins.
