COURSE DESCRIPTION: Introduction to the anatomy and physiology of domestic animals.

Students will develop a knowledge of comparative, gross, and microscopic anatomy of animals in addition to developing an understanding of the integrated functions of the body including biochemical and biophysical functions. At the completion of the course, students will understand the anatomy and function of the

major systems of animals.

ATTENDANCE POLICY:

ACADEMIC DISHONESTY:
