A bonus will be given for perfect attendance (No absences whatsoever). I will take attendance to keep a record of who attends class. You are allowed 3 hours (2 class periods) of absence, excused or unexcused, without penalty. This will also benefit in borderline situations. When you have exceeded 4 absences

(6 hours) you will begin to loose 5 points per absence to your total points (**This deduction will include the previous 4 absences**). Ex: you have 430 points and 8 absences, (8*5=40) your new point total will be 390. That is the difference in a letter grade. In order to do well in this class, you must attend lecture & exercises.
