Course goals:

As technology continues to develop and natural resources decrease, our abilities and intelligence to respond and adapt to environmental changes are constantly challenged. Term project:

Working in groups of 2-3, students will present an end of semester report on some aspect of the environment. Select a topic which interest you and that you believe will be of interest and have practical application to the other students in the class. Some of the better reports from past semesters have brought a "field trip" into the classroom with slide shows and visuals from an interesting location, or have presented the information in a "how-to" manual, giving specific but practical suggestions and guidelines concerning taking action to live in a healthier environment. On the date of your presentation, you are expected make a professional presentation to the class and turn in a 1-2 page summary sheet of your project.

Attendance:

Abstract assignments:

On assigned Thursdays, beginning on September 20, each student will bring a onepage, typed abstract of a current article dealing with an environmental issue. Articles must be 2000 or later. Briefly summarize the article and provide a personal reaction to its content (see example). Be prepared to discuss the article in class. Each abstract is worth eight points, and will not be accepted late.

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
