COURSE GOAL:

Drugs pervade our culture and our society, and a thorough grasp of health promotion must include an understanding of the impact that these substances have on our population. This course will focus on drug use, abuse, and addiction with an emphasis on recreational drugs. Approaches to prevention, intervention, and treatment will also be studied.

COURSE OBJECTIVES:

At the conclusion of this course, the student will be able to:

- 1. track the current trends in drug use and abuse in the United States.
- 2. describe the physiological and psychological effects of drugs.
- 3. explain the factors that influence drug use among various population groups.
- 4. list and define the actions of the categories of drugs of abuse.
- 5. define terminology related to general drug concepts and specific drugs.
- 6. describe various prevention, intervention, and treatment approaches to drug abuse.
- 7. relate the role of drug laws and law enforcement to the prevention of drug abuse.

Course Structure:

The course will be divided into four modules. Each module has a designated open and close date. The module requirements will be posted into the *Assignments* folder of blackboard on the first day of the module. All assignments must be submitted by midnight on the closing date of the module. Discussion boards will have participation deadlines to insure full participation by all students. Additionally, a term paper is due by December 7.

Abstracts and Term Paper:

Abstracts: One or two abstracts will be assigned for each module. Summarize a current (2002 or later) article pertaining to any drug or drug related issue. The articles may come from **any reliable journal or periodical**. Provide reference for the article (APA style). Fit the abstract and your reaction to the article on one page. Be sure to place your name, unit topic, and abstract number at the top of the page.

Term paper: Each student will research a specific current drug issue of their choice and prepare a 3-5 page written report on that topic. You are encouraged to select a topic that you find particularly interesting or applicable to you future career goals. Spend quality research time and be thorough enough to become an "expert" on the topic. Use APA citation style (http://www.shsu.edu/~wctr/handouts/APA_references.pdf.) Due date: December 7 by 5:00 p.m.

Quizzes:

There will be one or two quizzes for each module. They are multiple choice and true false questions developed by the publisher of the textbook. They are intended to make sure you get the basic content from each chapter. The quizzes contain 40 or 50 items, each worth one-half point each. The six quizzes will total 140 points. You have 3 hours to take the quiz, but I do not think it will take you that long. You may have your book open as you take the quizzes – in fact, I would think that will be necessary.

Exams:

We will have two exams worth 75 points each. They will include short answer, definition, essay, listing, and fill in the blank type questions. I have not yet decided if they will be take home or if we will need to make arrangements for you to come to campus. If you must come to campus, I will be very flexible to accommodate your schedules.

Student absences on religious holy days policy:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose.
