Course Requirements:

Each student will complete 2 exams (mid-term & final)

ARC Certification Requirements

Must pass with an 80% on all ARC exams  
Must pass CPR/SFA practical exams  
Students cannot miss more than 2 days.

## Attendance Policy:
