# MUS 117: SINGER'S DICTION: ENGLISH/ITALIAN 1 HR CREDIT

# **Course Description**

- This course is designed to familiarize singers with the accurate pronunciation of the English and Italian languages as sung in solo vocal repertoire (recital literature and opera) and
- choral music.

## Course Objectives

- Each student will ultimately become independent in translating, pronouncing, and singing English and Italian texts by properly using the International Phonetic Alphabet as a guide.
- To learn and employ the International Phonetic Alphabet (IPA) by confidently and accurately identifying the correct phonetic symbol for the given text and articulating the correct sound for the phonetic symbol.
- To successfully apply the knowledge of the IPA symbols in written, spoken, and sung exercises.
- To understand and apply the rules for using IPA in song literature, operatic literature, and choral repertoire.

### **Course Activities**

- Learn IPA through practical applications of worksheets, in and out of class.
- Listen to a CD of both English and Italian songs and arias for correct pronunciation and to apply the listening and IPA rules during class activities and homework. Five copies of the CD will be in the listening lab in the music library for students.
- Phonetically translate or transcribe both English and Italian song and to recite and sing the selections during class time.

## Attendance Policy

- Mandatory attendance is required for this course due to the nature of the content. Students must be present to hear the sounds that are represented by the symbols in IPA in order to apply them correctly.
- After 3 absences (excused or not), the student's final grade will be dropped one grade level (example: from a B to a B-).
- Every 3 "tardies" will equal one absence.
- If you are going to be absent due to illness or family emergency, please email me **before** you miss class. Bring a physician's note to class, and then I will consider clearing the absence off your record.
- School related absences will not affect your grade. Be sure to obtain documentation to support your absence.

### Missed Homework and Exams

- No exams will be made up unless there is a medical emergency the day of the exam. A physician's note is required.
- Homework will be due at the beginning of every class. It will be accepted up to one week late (including at the end of class when it is due), resulting in a 10 point deduction in your grade for each day late.
- If a student is absent on a day homework is due and <u>has not</u> missed more than 3 classes, the homework must be turned in the very next class day *with no penalty* (the assignment must be dated correctly). After 3 absences, the homework must be turned into my box before the beginning of class when the homework is due. Otherwise, it will be graded as the second bulletin states above.
- If a student is absent for the scheduled In-Class Performance, he/she must communicate with the Instructor 24 hours in advance via email (mus\_mkl@shsu.edu).
  - o Illness is the only excused absence for this grade, and the student will have no grade penalty.
  - o If the student is absent due to any other reason (besides university sponsored activities accompanied by a note from the sponsor) a deduction of 20% automatically applies for the performance grade.
  - o The performance will be rescheduled for the end of the semester, unless it can be coincided during a class time due to another absence.
  - o If a student fails to notify the instructor about an absence for the In-Class Performance, the result will be a zero for that performance grade.

- Quizzes
  - Two pop quizzes during the semester
- Midterm
  - o October 3, regular class time
  - o English portion: Will consist of written and listening requirements
  - o Will cover IPA rules
- Final (2 sections)
  - o Section One: 12/05, during class time. If not enough time applies due to number of students in the course, an extra time will be allotted, TBA.
    - Sung portion only (Italian) will be performed by memory
    - Each student is required to wear appropriate recital performance clothes
    - Your teacher will assign an Italian song/aria for you to perform for your final. You must submit this song on 10/03. 6 lines of text must be included in the selection.
    - Typed transcription and translation of the selection chosen for the final is due 11/21. After corrections are made, a copy must be presented to the entire class on 12/05.
    - The entire class will be present during the entire sung portion of the final.
    - A collaborative artist is REQUIRED for the final. Please plan ahead of time so the needs of both parties are met. A collaborator may be provided with a minimal fee for the student; however, if one is not available, the student must hire another collaborator for the final. The instructor will keep the students updated about this situation!
  - o Section Two: During Final Exam Week.
    - Written test will cover IPA rules (comprehensive)
    - English and Italian diction are covered on the exam
      Spoken Italian is a component of this section of the exam

#### **Special Assignment: In-Class Performances**

• Each student will participate in one In-Class Performance during the semester.

- Some students will sing in English, and some in Italian.
- Each selection must be **memorized** for the In-Class Performance.
- Each student will rehearse, in class, the Italian song selected for the final at the end of the semester. These performances are working rehearsals and memorization is not required. (Note: memorization is required for Section One of the Final, however.)
- See Missed Homework/Exams above for policy for being absent for the assigned In-Class Performance.

#### **Academic Policy**
