## **COURSE DESCRIPTION**

MUS 226 is an introduction to the basic techniques of conducting music. The course will offer a balance between theoretical studies related to the art of conducting and a laboratory setting used to develop beginning/intermediate level skills and refine specific techniques.

Prerequisite: Sophomore standing.

## **COURSE OBJECTIVES**

- 1. To gain an understanding of the extensive role of the conductor.
- 2. To give each student an understanding of the impact of the physical aspects (posture, stance, facial expressions, etc.) of the conducting gesture on the effectiveness of his/her work in both rehearsal and performance.
- 3. To develop skills use of both hands and the baton in conducting gestures.
- 4. To learn the basic, traditional time-beating patterns in both simple and compound patterns as well as an overview of asymmetrical conducting patterns.
- 5. To develop the use of active, passive, and expressive gestures.
- 6. To develop the conductor's gestures of preparation, appropriate releases, the ictus and the rebound.
- 7. To develop skills in using the non-baton hand in conducting.
- 8. To develop skills in the use of appropriate cues and gestures.
- 9. To learn musical terminology appropriate for and used in score study.
- 10. To learn basic transpositions and clefs (treble, alto, tenor and bass).
- 11. To develop an understandings of the use of dynamics, tempi.
- 12.To develop skills to effectively use sub-divisions of beats.
- 13. To evaluate conductors based upon a set of predetermined criteria.
- 13.To give the student the opportunity to conduct an in-class performance of his/her peers.

**General Information:** Students must bring baton, textbook, and composition books to class daily. Students will be required to take class notes – these notes will be included in the required portfolio. Additionally, students will be asked to bring instruments and parts/musical examples later in the semester, when announced. It is the student's responsibility to obtain ALL course materials before the end of the second week of classes.

Additional Course Materials will be distributed and must be included in the required conducting portfolio (the three ringed binder).

## 1. Conducting Practica/examinations/evaluations

This portion of any conducting course is the time in which the student applies the theory and principles associated with the process of learning to conduct. Each conducting evaluation will be added together with all others to arrive at an average for the entire semester. Conducting grades will be weighted toward *growth and improvement* that should occur over the course of the entire semester.

If you are ill on the day in which an exam is scheduled, your work must be made up during the class meeting following the illness provided your absence is **officially excused**. Otherwise, **no make-up exam will be allowed**.

**2.** Conducting Final – students will conduct a pre-determined selection of music and be evaluated on all aspects we have covered in the class. As mentioned earlier, conducting grades will be weighted toward *growth and improvement* that should occur over the course of the semester.

**Attitude** – a cooperative, pleasant working relationship in class is appreciated and expected.

## **Related Conducting & Academic Studies**

- **1. Daily work** Review of articles, class participation, and attendance. --A grade of F will be given to any work which is not handed in at the assigned time. **There will be no variation in this policy.** If you are away from class on University business, your work must be handed-in before you leave on business or at the next class period. If you are ill and have a doctor's report of your illness your work MIGHT be accepted.
- **2.** Written Examinations the mid-term and final are cumulative...everything we've covered can be on those exam.
- **3. Conducting Journals:** Each student will be required to keep a conducting journal for the duration of the semester. All materials (including handouts, writing assignments, tests and quizzes will be included in the journal. YES appearance of the journal will count as well. The must be neat, well organized and complete.

## **ATTENDANCE:**

#### **General Information on Attendance:**

- 1. Students will not be penalized for two or fewer absences
- 2. A student's final grade will be lowered 10 points (one letter grade) for each absence past the 2nd absence
- 3. A student's final grade will be lowered 1 point for each tardy (Two tardies will be considered as one absence.)
- 4. A student is counted as being in attendance when:
  - a. The student is physically sitting in his/her assigned seat
  - b. The student has all materials necessary to perform the class activities as required
  - c. The student and the instrument are properly warmed-up (as assigned)
  - d. The student is attentive and ready to participate in class
- 5. Students are provided a daily sign-up sheet on which to record their attendance. It is the student's responsibility to insure that the sheet is signed.

## Attendance and punctuality are required.

Should any variance occur, direct communication is *expected*. (**Document each/every communication by e-mail, please.**) Assignments **will not** be accepted past the date for which they were announced except in extreme cases. Special permission must be received from the professor for these cases.

The University catalogue states that in a regular class "A student shall not be penalized for three or fewer hours of absences when examinations **or OTHER ASSIGNED CLASSWORK have not been missed;** however, at the discretion of the instructor, a

student may be penalized for more than three hours of absences (2 class meetings for T-day classes)."

In any performance-based the final grade is affected subjective judgment by the instructor. Among the most influential factors on a student's grade in class are <u>ATTITUDE</u> and <u>ATTENDANCE</u>, <u>PREPARATION</u> and <u>"PERFORMANCE."</u> As you surely would assume, these four factors override almost all others. **Cooperation** is expected.
