Course Objectives:

The objective of this course is to explore the array of diseases affecting the systems of the human body and gain an appreciation for maintaining a healthy state of being through proper nutrition, life-style and disease prevention.

Upon completion of this course, students should be able to:

- 1) Understand the general mechanisms of disease
- 2) Understand the bodies defense mechanisms against disease
- 3) Understand the bodies healing processes following disease and injury
- 4) Be familiar with the specific, common diseases that affect each of the bodies organ systems
- 5) Appreciate the role of the medical system and medical provider in the diagnosis and treatment of disease
- 6) Understand the role of healthy lifestyles and hygiene in disease prevention
- 7) Gain a basic understanding of medical and disease related terminology

Attendance Policy:

Attendance is expected and very likely necessary in order to do well in this class. Attendance may be a consideration on borderline grades. All religious Holy Days will be honored. If it is not a nationally recognized Holy Day in this country, please notify in advance of your absence.

I am still a practicing physician with a busy practice. It is possible that I may be required in an emergency situation elsewhere. In this case, I will make every effort to inform the class of this prior to the class starting or have it posted on the door. If I am more than twenty minutes late, you can assume you have a “walk” and be dismissed.

There will be three major exams and a final exam. There will also be a small project required.

Project:

Within the first 2-3 weeks of class, I will distribute a list of topics. You will choose from this list of topics for your project and the guidelines for completing it.

Test Taking Policy:

You only have the opportunity to make up a test if:

You have a documented medical absence on the day of the exam; or

You have a prior approval from me in writing. This does not include e-mail.

My Cell Phone Policy:

As I stated, I am still in a full time practice. It is likely that I will receive a page or a call on my cell phone for medical questions pertaining to my patients. I am generally able to keep my responses sufficiently brief that it will not cause a significant disruption to the class. I suspect it will be a rare occurrence that one of these will result in my leaving the classroom to respond.

Electronic Devices:

Laptops are welcome so long as the content on the screen is directly related to the subject at hand. If I find anything else, you will be asked to leave, no exceptions. PDA's may also be used for scheduling purposes. No electronic devices will be allowed during exams.

Academic Dishonesty:

Students are expected to maintain honesty and integrity in the academic experience, both in and out of the classroom.

Classroom Rules of Conduct:

Students are expected to assist in maintaining a classroom environment that is conducive to learning. Students are to treat faculty and students with respect. Students are to turn
