The effective health educator has to be able to facilitate, motivate, persuade and negotiate. All of these skills require effective modes of communication. The goal of this course is to explore the different modalities of communicating health issues and information to audiences in a variety of settings in addition to learning to do so in a comfortable and confident manner. It is also the goal of this course to assist students in the acquisition of hands-on experience in applying some of these modalities.

- Identify and practice active listening
- Identify and practice verbal skills on a one-on-one basis
- Learn how to speak effectively and confidently in public
- Identify and exercise effective writing skills
- Design and produce print materials for health education
- Design and produce visual aids for presentation
