- 6. Course Description: Topics include special products and factoring, rational expressions and equations, rational exponents, radicals, radical equations, quadratic equations and complex numbers, and introduction to the function concept and graphing, equations of lines and linear systems.
- 7. Attendance policy: You are expected to attend every class and to arrive on time. If a class must be missed, then you are responsible for getting material that was missed.
- 8. Assignments: Homework will be assigned each class period and will help you succeed in this class. There will be quizzes given throughout the semester.
- 9. Tests: There will be 4 100 point tests during the semester and a final exam. The test dates will be announced ahead of time. You are expected to take all your tests with the class at the scheduled time. As a rule makeups are not given. If there is an emergency, please contact me immediately.

Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.
- 14. Visitors in the classroom: Unannounced visitors to a class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instuctor's discretion whether or not the visitor will be allowed to remain in the classroom.

This policy is not intended to discourage the occasional visiting of classes by responsible persons. Obviously, however, the visiting of a particular class should be occassional and not regular, and it should in no way constitute interference with registered members of the class or the educational process.
