Course Description: Theory of Modules and an Introduction to Commutative and Homological Algebra

Prerequisite: Math 677 or by professor's consent.

It is the responsibility of the student to obtain all course materials at the beginning of the semester.

Course Objectives: Students completing this course should have mastery of the following major concepts. Other techniques and ideas will also be covered.

Attendance Policy: Regular and punctual attendance for this course is mandatory and will be recorded throughout the semester. The student is responsible for obtaining any assignments or notices given during the date of their absence. Assignments: Homework will be assigned regularly. Students are expected to complete the assignment by the due date assigned. Students are expected and encouraged to work cooperatively on these assignments. However, those working together must give credit to their collaborators by appending their names at the top left corner of the first page of the written solutions. An oral quiz will be given based on the assignments and topics covered. The results will serve as the homework grade. If a university-approved absence is expected on this date, the student must hand in the homework prior to leaving. If an unexpected

absence occurs on this date, the student must see the professor before class.

Exams: There will be one (1) in-class written midterm exam and (1) scheduled oral midterm exam and (1) in-class written final exam and (1) scheduled oral final exam. The final exam is cumulative and will be given on Wednesday, May 14 from 8:00 a.m. to 10:00 a.m. The written midterm exam is tentatively scheduled for Wednesday, March 26. For any university-approved or documented absence, the student must contact the professor before the day of the exam to make arrangements for examinations. Otherwise, no make-up exams will be administered.
