Text: Statistics: Principles and Methods, 5<sup>th</sup> Edition, Johnson and Bhattacharyya

Course Objective: To develop an understanding of and a facility for the concepts and applications of descriptive and inferential statistics.

Course Description: This course covers the fundamentals of statistical concepts and will guide the student through basic statistical procedures to permit critical insight into the science of collecting, classifying, presenting, and interpreting information from data. The three primary topics are covered. The first topic is descriptive statistics (graphic presentation of data, histograms, plots, charts, measures of central tendency, dispersion, and position, bivariate data analysis, linear correlation and regression analysis). The second topic is probability concepts and rules for calculating probabilities of compound events. The probability coverage also includes the more commonly occurring probability distributions such as the binomial and normal distributions. Finally, the third area of coverage is that of inferential statistics, including inferences involving one and two populations. Students are also introduced to MINITAB software.

Prerequisite: 3 semester hours of mathematics and consent of instructor

Exams: There will be 3 mid-term exams and a mandatory comprehensive final exam. Exam dates are scheduled for Feb 14, March 20, and April 22. The final exam will be held on May 13 (8am-10am). *Makeup exams will* <u>NOT</u> be given. The lowest exam grade may be replaced by the comprehensive final exam.

Homework: Suggested homework assignments are given for each section. This list of problems will be the *minimum* necessary for a full understanding of that material. You are certainly invited to do more. Select problems will occasionally be collected for a grade.
