Course Objective: To develop an understanding of and the facility for the theory and applications of probability and distributions.

Course Description: Topics include multivariate, conditional and marginal distributions, point and interval estimation, theory of estimation, maximum likelihood estimates, hypothesis testing, likelihood ratio tests, contingency analysis, and nonparametric statistics.

Prerequisite: MTH 244 and MTH/STA 471

Exams: There will be 3 mid-term exams and a mandatory comprehensive final exam. Exam dates are scheduled for Feb 14, March 20, and April 22. The final exam will be held on May 15 (11-1). *Makeup exams will* <u>NOT</u> be given. The lowest exam grade may be replaced by the comprehensive final exam.
