Course Description: Topics covered come from introductory algebra, functions, graphs, systems of equations and matrices, and mathematics of finance. Applications of the mathematics to "real-world" problems is emphasized. The class is primarily a lecture class. Material will be taken from Chapters 1, 2, 3, 5 and 6 of the text. Not all sections will be covered. Homework problems will be assigned. These are neither collected nor graded. These should be considered to be the minimum number of problems a student should work. Many students may need to work more problems in order to master the material.

Prerequisites: Two years of high school algebra and one year of high school geometry.

Course Objective: The successful student will acquire the mathematical skills necessary to analyze and solve certain types of applied problems.

Text: Mathematical Applications for the Management, Life, and Social Sciences 8th edition by Harshbarger and Reynolds. Houghton Mifflin publisher.

Required Calculator: A TI83, TI83+ or TI84 + is required for the course. These are the only calculators permitted to be used on a test. Exception: If you intend to use another calculator on a test, it must be approved at least one day before the test by the instructor. This approval is not to verify the calculator is appropriate for the test, it is only to verify that the calculator does not give you an unfair advantage on the test.

Exams: We will have 4 tests and the final, each of which will have a value of 100 points. The tests will primarily be problems similar to homework problems or examples I have worked in class. However, you will also be responsible for definitions, theorems and formulas as developed in the book and class. It is not anticipated that there will be extra-credit work. If you miss an exam due to doctor's excused illness or officially approved university activity, you are entitled to take a make-up exam. If you miss an exam for any other reason, it is at the discretion of the instructor as to whether you may take a make-up exam. In either case, you must be prepared to take the make-up when you return to class. When you take the make-up will be determined by the instructor.

Grading: The 60%-D, 70%-C, 80%-B, 90%-A grading scale will be used. No test grades

are dropped. All test grades will be used in calculating the grade. I reserve the right to lower the grading scale at the end of the semester, if I deem it appropriate.

Attendance: Attendance will be taken every class period. In order to facilitate the taking of attendance, a seating chart will be developed. If you come to class late, it is up to you to visit with the instructor immediately after class to see if you can be counted present. There is no such thing as an excused absence. If you are not in class, you will be counted absent.

Classroom Decorum: You are expected to behave in a polite and courteous manner at all times in the classroom. Cellular phones and other chiming devices must be turned off before class begins. Under no circumstances are cell phones or other electronic communication devices to be used or seen during times of examination. Any such use will result in your examination being immediately collected and you will receive a grade of zero on the exam. You are prohibited from using any tobacco products in class, making offensive remarks, reading newspapers or other material not pertinent to the class, sleeping, talking at inappropriate times or engaging in any other form of distraction. Unless other arrangements have been made, you will remain in class until the class is dismissed. Inappropriate behavior in class, may result in a directive to leave class and you will be counted absent. Especially disruptive behavior may be reported to the Dean of Students for disciplinary action in accordance with university policy.

Academic Dishonesty: You are expected to engage in all academic pursuits in a manner that is above reproach. You are expected to maintain complete honesty an integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, collusion and the abuse of resource materials.
