INTRODUCTION TO CRIMINAL JUSTICE

Course Description:

This course will provide students with an introduction and overview of CRIMINAL JUSTICE, both as a system and as a process. Recognize crime as one of the most serious problems facing our society today. The primary mechanism for dealing with the problems associated with crime is the CRIMINAL JUSTICE SYSTEM, with its three operational components of LAW ENFORCEMEMT, COURTS, and CORRECTIONS. We will explore the organization and operation of these agencies; focus on the major decision makers and the processing of criminal offenders through the system. Additionally, we will examine the criminal law, causation of crime; study some criminals, protection of individual rights and the purposes of punishment. Finally, you will acquire the language of Criminal Justice known as "Legalese."

Course Objectives:

- 1. Provide a solid foundation of valid information about the subject.
- 2. Provide opportunities to process and think about the information.
- 3. Promote critical thinking, decision making, problem solving and communication skills.
- 4. Encourage individual participation and group discussion.
- 5. Enhance essential skills of reading, writing, research through special assignments.
- 6. Provide a way to demonstrate acquired knowledge and understanding of the information.
- 7. Extend learning beyond the classroom.
- 8. Introduce students to employment opportunities.

Strive to make this class one that the students actually look forward to coming to each week and one they will remember forever.

Attendance Policy:

- 1. Regular and punctual class attendance is expected of each student.
- 2. Students are expected to remain in each class session for the full time period.
- 3. Individuals not officially enrolled in our class are not permitted to be present (except guest speakers selected and authorized by the instructor).
- 4. The instructor is required to take regular class attendance and maintain a record of student attendance.
- 5. Class attendance will be recorded and counted from the actual day of enrollment for the individual student in this specific class.
- 6. A student may be penalized for more than three (3) hours of absence.

- 7. For each additional absence five (5) points shall be deducted from the final grade average.
- 8. Students are expected to show appropriate cause for missing or delaying assignments or examinations.
- Students are expected to personally meet with the instructor to arrange for accepting late work or making-up tests, prior to the next class period.
 Failure to accept this responsibility by the student results in receiving a zero grade.
- 10. Students are expected to perform assigned reading and acquire class information for any class sessions missed due to absences.
- 11. A personal telephone call to the instructor, prior to any class, concerning attendance and assignments is appropriate and encouraged.
- 12. Students with perfect attendance and maintaining an "A" average on all tests and assignments <u>prior</u> to date of the final examination can request and receive an exemption from talking the course final. The accrued average grade will be your grade for the course.

Grading Policy:

- 1. There will be three (3) tests scheduled and administered during our class time for the semester.
- 2. A short review may be provided during class time prior to administering each test. Please know that this review likely will not cover all the test questions. All tests are taken without use of any assisting materials.
- 3. Each test will have the value of 100 possible points.
- 4. Each student will be assigned six (6) writing assignments. Completion of each assignment will have value of 100 possible points. Specific information will be provided when the assignments are made.
- 5. To promote the importance of assigned textbook reading, students should expect and be prepared to answer in writing a single question each class. The question derived from the assigned reading can be answered by completing the reading.
 - Each question has the value of five (5) points. The total points possible for this assignment will equal 100 points (20 questions from random weeks); you either make a $\underline{5}$ or $\underline{0}$ for each question. Failure to turn in the assignment for any reason results in a grade of zero (0).
