COURSE DESCRIPTION: This is an advanced course for those wanting a more thorough dominion of Spanish syntax and composition. Prerequisite is SPN 361W or the equivalent. Students improve their composition skills in Spanish through reading, speaking, listening, writing and grammatical analysis. The course prepares the student by stimulating the development of vocabulary and by encouraging practice in strategies for effective written expression. Students are expected to use the language within the limits of their developing skills, to participate actively in class and to prepare assignments on time.

## **OBJECTIVES OF THE COURSE:**

Students improve their composition skills in Spanish through reading, speaking, listening, writing, grammatical analysis and practice. The course prepares the student by stimulating the development of vocabulary and by encouraging practice in strategies for effective written expression. Students are expected to use the language within the limits of their developing skills, to participate actively in class and to prepare assignments on time. SPN 461 is designed to expand the student's proficiency in writing in Spanish by exploring and practicing the different steps in the writing process. We will cover four different writing formats: description, narration, exposition, and argumentation. Students will learn to use dictionaries and other resources to help themselves write with a high degree of accuracy.

## **GOALS OF THE COURSE:**

The principal goal is that by the end of the course, the student will be able to write a coherent, well-organized essay in Spanish, using consistently clear and grammatically correct language, accurate spelling, professional vocabulary, appropriate punctuation and transitional elements, in such a way that a native speaker would be able to read and understand the essay well.

<u>COURSE FORMAT:</u> The class meets three hours a week. The classroom will provide the necessary background for learning, but much individual effort outside the classroom is essential to develop the Spanish language skills that are the goals for this course.

TEXT: <u>REPASE Y ESCRIBA</u>: <u>CURSO AVANZADO DE GRAMATICA Y COMPOSICION</u>. Fifth Edition. María Canteli Dominicis y John O. Reynolds (Do <u>NOT</u> purchase the workbook.)

**ATTENDANCE:** Everyone is expected to attend all classes and to participate actively in class activities. Absences and tardiness are frowned on by professor. You are allowed a total of two

absences without penalty during the semester. Use these absences wisely because all absences for whatever reason (illness, athletic event, religious holiday, etc.) count. If you are absent more that 2 times during the semester one point will be deducted from your final percentage grade for each absence in excess of two. Two tardies equal one absence.

If you have a serious illness or a death in the family, it is appropriate for you or a parent to notify the Office of Student Life, 409-294-1785, as soon as possible. They then notify all of your teachers.

**ASSESMENTS:** Students will be evaluated in a variety of ways throughout the semester for their skills in listening comprehension, reading, writing, speaking, as well as grammatical and cultural knowledge. However, since this is a writing-enhanced course, written expression will be the major emphasis of the course. Evaluations for the course will be distributed in the following way:

- **A. TRABAJOS: 80%** A series of formal compositions covering various topics, based on rough drafts begun in class, then polished with help and feedback from the professor and classmates, and, after several drafts, turned in for evaluation. Always staple the latest draft on top of all earlier drafts. Three of these compositions will be done in the lab (EV 212); one of these will be at the time of our final exam (May 15, 2:00-4:00 p.m.)
- **B. PRUEBAS: 20%** These will be brief quizzes on reading assignments, grammatical points and vocabulary. There will be no makeups for these quizzes.

# THE GRADES FOR YOUR ESSAYS WILL BE BASED ON THE FOLLOWING CRITERIA:

- SUPERIOR-- Un trabajo superior se dirigirá a todos los aspectos de la tarea bajo cuestión. Estará bien organizado con suficientes detalles y, en general, bien redactado. También demuestra originalidad en las ideas y en la expresión. Utiliza el registro apropiado, un vocabulario amplio y pleno dominio de estructuras gramaticales complejas, sin ningún error de concordancia. No tendrá ningún error de ortografía ni acentuación. Tampoco tendrá ningún problema de puntuación. (95-100 pts.)
- 5 MUY BUENO-- Este trabajo tendrá muchas de las características del trabajo superior, pero tendrá unos pocos errores de ortografía, acentuación o puntuación. (90-94)
- BUENO-- Estas calificaciones se designarán a trabajos que sean buenos pero que demuestran alguna debilidad que no tiene el trabajo superior. Puede ser que le falte desarrollo, o que no esté tan bien organizado como el trabajo superior o que tenga problemas gramaticales menores. No demuestra originalidad, ya sea en las ideas o en la expresión. El vocabulario es más limitado que el de un trabajo superior, pero hay un dominio de estructuras gramaticales sencillas. Posiblemente utiliza un registro inapropiado. Tal vez tenga algunos errores de ortografía, acentuación o puntuación. (80-89 pts.)
- 3 SUFICIENTE-- Este nivel de trabajo demuestra poco desarrollo de las ideas, posiblemente repetitivo y, por lo general, superficial en cuanto a ideas. No demuestra originalidad, ni en las ideas ni en la expresión. Este trabajo tendrá errores gramaticales, pero, por lo general, éstos no impedirán la comunicación. Tal vez tenga muchos errores de ortografía, acentuación o puntuación. (70-79 pts.)
- 2 BAJO-- Esta calificación es para trabajos que demuestran debilidades serias de estructura, desarrollo y cuestiones mecánicas. Se interrumpe la comunicación frecuentemente. Tiene muchos errores de concordancia y el vocabulario es inestable. Puede tener problemas serios de puntuación. (60-69 pts.)
- 1 INSUFICIENTE-- Esta calificación es para trabajos que no demuestran una comprensión de la tarea bajo cuestión o revelan una obvia incompetencia en la lengua española. (0-59 pts.)
