#### \*DESCRIPTION OF COURSE:

A class for students who have completed Spanish 141, 142, and 263 at SHSU, who have completed equivalent courses at other institutions or have taken the CLEP and placed out of those courses. This is the final course for the foreign language requirement for some degree plans. Students should demonstrate intermediate or higher levels of pronunciation, vocabulary and language codes stressing oral ability, reading ability, and writing ability. Special emphases on reading, writing, and speaking. Prerequisites: having passed 141, 142, and 263 with an average of C or better, or placement by testing

#### \*STYLE

This course has two delivery methods: an on-line BLACKBOARD for information outside class meetings and a SEMINAR-STYLE, student-centered, format in class meetings with a minimum of professor lecture. Spanish will be the preferred language in both in the majority of cases but code-switching may be practiced only when necessary. Since language is a social skill and activity, this is the only way to learn effectively. Be prepared to ask questions and receive answers in Spanish. Do not expect other students to translate for you. In either language, mistakes are natural--tolerance and assistance are the watchwords. Be flexible--think of another way to send the same message if you get "stuck."

- 6. ability to READ newspapers, magazines, and exerpts from books and report on what has been read at intermediate level or better both orally and in writing
- 7. ability to WRITE at least a paragraph in response to a question in Spanish with minimal errors in syntax and appropriate word choices.
- 8. ability to WRITE an essay of 300 words or more on a topic for which the student has prepared. [short autobiographical sketch, description of a room or a person, etc.]

# \*COURSE OBJECTIVES (Optimal activities)

- l. To <u>LISTEN</u> to and comprehend at an intermediate or higher level examples of standard Spanish spoken at average native speed
- 2. To <u>SPEAK</u> without notes (and read aloud) at an intermediate or higher level examples of standard Spanish with few enough pronunciation errors (speed secondary) to be comprehended by a native speaker
- 3. To <u>READ</u> and comprehend at an intermediate or higher level examples of standard Spanish by concentrating on major words known (with the help of cognates) and by making educated guesses at the rest. With the further help of a dictionary, to be able to comprehend a high percentage of standard Spanish
- 4. To <u>WRITE</u> at an intermediate or higher level in standard Spanish with few enough grammar errors to be comprehended by a native speaker
