Course Description

In this introductory course, you will learn how to evaluate public programs. That is, how to develop strategies for doing an evaluation, implement them, derive meaningful conclusions and then decide on the future course of action.

Course Objectives

The main emphasis will be on how to design and conduct an evaluation. The course will introduce the different types of evaluations that are available to assess programs, teach how to pose relevant questions and choose an appropriate design for evaluation that would help to answer the main question in the study. It is through the design and execution of an evaluation plan that one can develop awareness of the methodological, administrative, and political constraints associated with any project. So, this class will help to create an awareness of obstacles and the many challenges that are encountered in the course of an evaluation. Throughout the course, the emphasis will be on a practical hands-on approach in conducting evaluations.

REPORT ON RESEARCH:

A complete research report has to be submitted followed by its oral presentation. For your oral presentation, use powerpoint slides and be prepared to answer questions that might be posed by other students and the instructor. You should present your findings as succinctly as possible and use visual aids like graphs, charts, schematic diagrams and others to convey the logic of reasoning or findings of your study. You must inform the audience the obstacles/challenges that you may have encountered in the course of your study and how you had overcome them. Please do not forget to mention the implications of your study in your presentation.

Written Report:

Your written report will follow the Guba style using the Turabian citation method. You will report the identification of the problem, research questions, identification and measurement of the variables (parts of the research design you have already prepared can be used). The newer

part of your report will explain the collection of the data and the findings. The findings should be related to the hypotheses you had already written and the criteria you used to determine whether a hypothesis is true or not. You will need to show that you have ruled out rival explanations that might also explain a cause. The various threats to validity should be clearly stated. Lastly, you will need to explain the "meaning" of the findings and discuss its utility in the field of public administration.

As you read for this course, particularly Bingham and Felbinger, you will get ideas of how these reports are supposed to look and the type of information you need to include. Bingham and Felbinger's examples are part of published literature, so they are "peer reviewed" and have been scrutinized. Thus, they are examples of "good" research. Keep that in mind as you read them.

Ordinarily reports of this magnitude can be quite long. I would encourage you to keep your report under 100 pages, including appendices and works cited.

Remember to follow Turabian style and the SHSU Manual for Theses. You will need

- > chapters and chapter titles so you will need a table of contents.
- > use a works cited, NOT a bibliography.
- > all tables are in Turabian format and must be included immediately after they are mentioned in a paragraph.

ACADEMIC DISHONESTY:
