*DESCRIPTION OF COURSE:

A class for students who have completed Spanish 141, 142, 263 and 264 at SHSU, who have completed equivalent courses at other institutions or have taken the CLEP and placed out of those courses. This is an advanced course for the foreign language requirement for some degree plans. Students should demonstrate higher levels of pronunciation, vocabulary and language codes stressing writing ability, reading ability, and oral ability. Special emphases on writing, reading, and speaking. Prerequisites: advanced standing, Spanish major or minor.

*STYLE

This course has two delivery methods: an on-line BLACKBOARD for information outside class meetings and a SEMINAR-STYLE, student-centered, format in class meetings with a minimum of professor lecture. Spanish will be the preferred language in both student discussion and lectures in the majority of cases but code-switching may be practiced only when necessary. Since language is a social skill and activity, this is the only way to learn effectively. Be prepared to ask questions and receive answers in Spanish. Do not expect other students to translate for you. In either language, mistakes are natural--tolerance and assistance are the watchwords. Be flexible--think of another way to send the same message if you get "stuck."

*GENERAL GOALS (Optimal results)

- l. increased AWARENESS of and APPRECIATION for Hispanic language and culture
- 2. at least advanced level <u>VOCABULARY</u> in Spanish, with emphasis on vocabulary for the world of work in the students' areas of study and the ability make educated guesses about unknown words based on context as well as to identify unknown cognates

- 3. ability to <u>CONJUGATE</u> regular, stem-changing, and irregular verbs in present indicative, present progressive, present and imperfect subjunctive, preterite, imperfect, conditional, present perfect and the other compound tenses and use standard orthography in Spanish
- 4. ability to carry on at least advanced level <u>CONVERSATIONS</u> related to visiting/living in a Spanish-speaking country, e.g., arrange and execute transportation, accommodations, meals, etc.
- 5. ability to carry on at least advanced level <u>SOCIAL CONVERSATIONS</u>, adapting to unexpected questions or responses
- 6. ability to READ newspapers, magazines, and exerpts from books and report on what has been read at advanced level or better both orally and in writing
- 7. ability to WRITE at least an essay of 500 words in response to a question in Spanish with minimal errors in syntax and appropriate word choices.
- 8. ability to WRITE an essay of 500 words or more on a topic for which the student has prepared. [short autobiographical sketch, description of a room or a person, etc.]

*COURSE OBJECTIVES (Optimal activities)

- 1. To <u>WRITE</u> at an advanced level in standard Spanish with few enough grammar errors to be comprehended by a native speaker
- 2. To <u>LISTEN</u> to and comprehend at an advanced level examples of standard Spanish spoken at average native speed
- 3. To <u>SPEAK</u> without notes (and read aloud) at an advanced level examples of standard Spanish with few enough pronunciation errors (speed secondary) to be comprehended by a native speaker
- 4. To <u>READ</u> and comprehend at an advanced level examples of standard Spanish by concentrating on major words known (with the help of cognates) and by making educated guesses at the rest. With the further help of a dictionary, to be able to comprehend a high percentage of standard Spanish
