Prerequisites: MCM 232/330 and MCM 262 or 284 or 374.

Description: Students will use techniques drawn from all media to produce well-designed, effective

communication packages for online distribution. Working in teams, students will integrate

written material, video, sound and graphics into a multimedia online publication.

Objective: To gain factual knowledge, learn fundamental principles, develop specific competencies

and creative capacities, learn how to find and use resources, and learn how to analyze

and critically evaluate online journalism.

Method:Instruction will include lectures, presentations, class discussion, hands on writing, research and

online production work, and assigned readings.

Assessment: Exams and quizzes may include true/false and multiple choice questions. Exams may

also include short answer and essay questions. Blog entries will consist of content posted on the student's personal online weblog, as well as comments posted on other blogs. Online journalism assignments may be submitted in written, audio, video, or graphic format, and will contribute to a group project resulting in an Online Journalism Review to

be published at semester's end.

Midterm: The midterm exam will be held on Mar. 6.

Final Exam: The final exam will consist of take-home essay questions.

Attendance: Attendance and participation are mandatory and will be used as the deciding factor in

grading. Students who do not provide a valid reason in advance for any unavoidable absence will not be allowed to make up any quiz or exam missed. Students with more than three unexcused absences may have their final grade lowered accordingly.

Note:

Only registered students may attend class. Exceptions can be made on a case-by-case basis by the professor. In all cases, visitors must not present a disruption to the class by their attendance. Students wishing to audit a class must apply to do so through the Registrar's Office.

All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, collusion and the abuse of resource materials.

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence. University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
