COURSE DESCRIPTION:

The purpose of this course is to give students an insight into the environment in which businesses operate and to provide them with a basic understanding of solving problems using legal rules. It may be elected by nonbusiness students.

COURSE OBJECTIVES:

Students will be expected to:

1. Develop the ability to recognize legal problems that arise in common business transactions.
2. Know selected legal rule and their impact on the decisions made in operations of businesses.
3. Develop the analytical thinking process by the application of legal concepts in the solving of problems.
4. Understand the environment in which business decisions are made and the effect of those environs on the decision process.

COURSE EVALUATION PROCESS

Three (3) major examinations = 25% each exam for a total of 75%
Final exam = 25%

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS

The penalty for excessive unexcused absences, which is defined as ten (10) hours, is automatic failure (a grade of "F") of the class. Also, those who miss a substantial number of classes will penalize themselves by missing material that will be discussed in class, that may not appear in the texts, and over which the class will be tested. If a student arrives late for class and the roll has been taken, the student is considered absent for the day unless otherwise corrected. Perfect attendance will be rewarded for "borderlines". (1 point to final average)

Any examination missed because of an absence must be made up at the end of the semester by all students who missed examinations, unless otherwise adjusted.
