Course Title: Principle and Policy in Information Assurance

Course Description

The rationale and necessity for securing computer systems and data networks, as well as methodologies for the design of security system, establishing security protocols and the identification of best practices in the administration, testing and response protocols for secure communications systems. Classes will be a combination of lecture, and group discussion. Exams, projects and homework are described in detail below.

Course Objectives

On completion of this course, students will:

- 1. Have an understanding and appreciation of basic security concepts and their application in a commercial or professional environment.
- 2. Be able to define and develop strength in depth organizational security policy and develop procedures for the implementation of such policy.
- 3. Define, establish and implement disaster recovery plans.
- 4. Have an appreciation for the utility and limitations of the National InfoSec model for Information Assurance.
- 5. Be able to ground Information Assurance principles in an ethical context.
