Course Title: Cyber Law

#### **Course Description**

This course will review the legal and regulatory issues faced by law enforcement, prosecutors, telecommunication service providers and users in the US as well as around the world. Students will learn law categories and types, case citation, internet law, cyber crime legal issues. There will be an emphasis on current and emerging changes in the field.

## **Course Objectives**

On completion of this course, students will:

- 1. Have an understanding and appreciation of basic cyber laws and their application in a commercial or professional environment.
- 2. Be able to define and work with legal and regulatory issues in a digital envirnment.
- 3. Be able to perform and complete legal research in a digital envirnment.

#### **Assignments**

On-line discussion will be a large part of your grade. Reading assignments will be posted to Blackboard. Each student will be required to read the assignment by the due date and post to the on-line discussion on

Blackboard. Each student will be required to post for each reading assignment comments and critiques on the subject matter just read. Comments and discussion are required from other students. Do NOT repeat back a synopsis of the reading assignment. Comments and discussion are to be based on original thoughts. Every Friday each student is to critique the thoughts and comments of the other students on the roster. Each classmate is to be rated from highest to lowest. DO NOT post the critique to Blackboard. Email this critique directly to me by midnight each Friday. Your grade will be based on critiques by classmates and instructor review. No harassment or profanity will be allowed. Please treat each and every classmate with respect.

#### Exams

The course grading system includes three tests and a final examination. Each of the tests will consist of a minimum of 10 short answer (1-2 paragraphs) questions. The final will be comprehensive. No make up tests/examinations will be allowed save for documented medical emergencies. ALL TESTS WILL BE TAKEN IN THE CLASS ROOM.

#### **Case Briefs**

Each week, you will be required to turn in 2 case briefs related to the reading assignment for that week. The briefs must be over cases that are NOT cited in the text. Turn in briefs by emailing to me.
