Course Objectives: After completing this course, the student will have learned

1. to develop the method and subject matter of economics.
2. the analysis of the workings of a market economy and a centrally-planned economy. Numerous variations of these two models will be examined.
3. to define, describe, and analyze concepts and characteristics of modern economic systems.
4. to develop tools and methods of analyses and compare economic systems. Some attention will be given to transition economies and to "Less developed" economies.

Course Evaluation Process:

Tests:

There will be three (3) tests during the term. Tests 1 and 2 will be worth 100 points each and may include essay-type questions, problems, and objective questions. The final examination will be worth 150 points, including approximately 50 points of comprehensive material.

Quizzes:

During the term (5) take home quizzes ("problem sets") will be assigned; each will have a value of 25 points. Ten points will be deducted for each day the quiz is late. The instructor reserves the right to assign quiz material to be completed "in class".

Make-up Exam:

In the event that a student is absent for a scheduled test, a single COMPREHENSIVE ESSAY, makeup text will be given toward the end of the semester.

Attendance:

Regular and punctual class attendance is expected; tests and quizzes are based on class presentations and also from text materials. Students can earn a maximum of 25 points based on class attendance. Points will be assigned as follows:

Final grades will be based on the percentage of total points (500 points possible) obtained during the term. Averages will be determined as follows:

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: “a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...” A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
