Lab Safety

PRIOR TO COMING TO LABORATORY, YOU MUST HAVE A PAIR OF DEPARTMENT APPROVED SAFETY GOGGLES. These goggles must be worn at all times in the laboratory. You will not be allowed to participate in the day's experiment or activities without safety goggles and will be counted absent with the loss of points associated with the experiment. Accidents occasionally happen, and chemical splatter is a common hazard in chemistry labs. Because of this, SHORTS AND OPEN SHOES WILL NOT BE ALLOWED IN THE LAB. Long hair must be tied back. If you show up for lab in shorts or open toes shoes you will not be allowed to participate and will be given a zero for that lab. More extensive safety requirements are located in the first few pages of your lab text and will be discussed the first day of class.

No make-ups are possible. If you miss a class period a grade of zero will be recorded for any experiment assigned for that day. Missing two labs will mean automatic failure for the course.

This course will provide laboratory experience in the areas of equilibria, kinetics, oxidation-reduction reactions, and thermodynamics.
