# FCS 269 Introduction to Textiles 3 hours credit Summer II 2008

<u>COURSE DESCRIPTION:</u> This course is focused on the study of fibers and their use in textile products. Emphasis is on the relationship of fiber properties, yarn structure, and finishes that produces a fabric suitable for specific consumer end uses. Emphasis also is given to identification of fibers and fabrics. FCS 269 is a required course for Teacher Certification in Family and Consumer Sciences.

## **CONCEPTUAL FRAMEWORK FOR TEACHER EDUCATION AT SHSU:**

Through programs dedicated to collaboration in instruction, field experience, and research, the candidates in Sam Houston State University's Educator Preparation Programs acquire the knowledge, dispositions, and skills necessary to create a positive learning environment. ### **COURSE OBJECTIVES:**

Upon completion of the course, the student should be able to:

- 1. identify careers in the textile industry.
- 2. know current law and labeling requirements.
- 3. describe the characteristics and uses of specific fibers..
- 4. describe various methods of constructing fabrics, such as weaving, knitting, non-woven, and other methods.
- 5. use textile terminology correctly.
- 6. describe how finishes are applied to fabric and how they affect fabric appearance, performance, durability, and

maintenance.

- 7. describe fabric design and the application of dyes.
- 8. develop systems for identifying fibers, yarns, and finishes.
- 9. identify sources of performance standards and standards available for voluntary use.
- 10. care for textile products in a satisfactory manner.
- 11. understand how production processes affect the characteristics and cost of textile products.
- 12. value past developments in textile construction and use, and recognize needs for future development.
- 13. predict fabric performance based on knowledge of fibers, yarns, fabric construction, and finishes in conjunction

with informative labeling.

- 14. predict good selection of textile products for specific end uses based on knowledge of fibers, yarns, fabric construction and finishes.
- 15. understand the environmental concerns, pollution potential, and safety concerns of fiber and fabric manufacturers.

## **CLASSROOM POLICIES AND PROCEDURES:**

- 1. There will be one make-up exam at the end of the semester at a time to be announced toward the end of the session (August 5, most likely). The student must have appropriate documentation (note from a doctor, an obituary notice that names the student as a survivor of the deceased, etc.) in order to take a make-up exam. **The make-up exam will be comprehensive.**
- 2. Assigned work turned in to the instructor must be the **original** work of the student turning in the assignment. See the comments regarding academic dishonesty in the section above.
- 3. Assigned work turned in for credit (i.e, Textile Swatch Notebook) **must** be word-processed or VERY neatly hand-lettered.
- 4. All assignments must be completed and turned in to the instructor before the final exam can be taken (*Undergraduate Catalog*, p. 74).

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable time frame in which the missed assignments and/or examinations are to be completed.

#### *Q-DROPS*:

Tuesday July 8

A Q-drop is a drop made after the last date for tuition refunds (12th class day for fall/spring; 4th class day for summer) but before the date for which a drop would result in a grade of 'F' as published in the Academic Calendar.

Students will be allowed no more than five Q-drops during their academic career at Sam Houston State University. Classes that are dropped prior to the Q-drop date will not count toward the limit. Students who have used their limit of five Q-drops will need to petition their respective dean to drop a class. If the dean refuses to grant permission to drop a class, a student will be required to remain in the class

This limit was effective with the start of the Fall 2004 semester. Any drops accumulated prior to the Fall 2004 semester will not be included in the five Q-drop limit, nor will Q-drops from other universities.
