COURSE DESCRIPTION: In indirect democracies, intermediary institutions such as political parties, interest groups, the media, and social movements, help link citizens to governments. In this course we will explore the nature and role of two of these intermediary institutions, political parties and interest groups. In the first section of the course we will examine the nature of interest groups and political parties, including the historical and philosophical context in which political parties and interest groups have developed. We will also analyze the functions that intermediary institutions play in democracies. In the second phase of the course, we focus on interest groups, specifically their organizational and institutional structures, their strategies and techniques, and their impact on politics and policy. In the fourth section of the course we will analyze the interdependence and interactions of parties and interest groups in American politics.

COURSE OBJECTIVES: My objectives for students in the class include:

- expanding students' knowledge base of political parties and interest groups
- -learning about the major principles, theories, models, methods that inform our study of political parties and interest groups
- -learning to apply the major principles and theories to understand current political phenomena
- -developing the analytical skills to critically evaluate ideas, arguments, and points of view

Research Project: The research project entails analyzing political party and interest group behavior on a specific policy issue. You will select a policy issue currently on the national government's agenda. Class Contribution: Your involvement in class is crucial to a successful learning experience. This requires regular attendance, preparation, and participation.
