Catalog Description: PHL 262 CRITICAL THINKING. [PHIL 2303] Designed to improve students' ability to think critically. The course covers the fundamentals of deductive reasoning, the identification of common fallacies, and an introduction to inductive reasoning, as well as sensitizing the students to some of the ways information is distorted, e.g., by advertising and news management. Credit 3.

Course Format: This course will be primarily taught in a lecture format. Students are encouraged to ask questions during the lecture.

Objectives: The primary objective of this course is to familiarize students with the techniques of logical analysis and argumentation. Toward this end, we will focus upon the following: 1) investigating the role of logic in clarifying one's own thinking, 2) examining deductive and inductive reasoning with the aim of understanding both the strengths and limitations of logic, and 3) developing the necessary skills for identifying common errors in reasoning. Upon completion of the course, students will be able to identify and avoid common errors in inductive and deductive logic.

Required Texts:

Vaughn, Lewis (2008) <u>The Power of Critical Thinking</u>: <u>Effective Reasoning About Ordinary and Extraordinary Claims</u> Second Edition. Oxford University Press.

Additional web-based readings will be supplied to supplement the text. These readings will be available at no charge to the students.

Supplies: All students must be prepared to provide their own full-sized scantron form for each exam.

Attendance Policy: Attendance records will not be used in determining your grade. Class attendance is strongly encouraged as all students are responsible for any material covered or assignments given in class even if it does not appear in the texts or on the website.

Make-up exams will only be given for documented medical emergencies. If a

student misses an exam without providing written medical documentation, a grade of zero (0) will be entered for that exam. The only exception to the above is an absence for a religious holy day covered under the policy on religious holidays.

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911(a)(2) defines religious holy days as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20, Tax Code...."

A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will notify the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.

Assignments: There will be a reading assignment for most class days. These will be posted on Blackboard. All students are responsible for reading assignments **BEFORE** class.

For some class days, I will assign homework problems that students are expected to complete prior to class and submit at the beginning of class. These will not be accepted late for any reason. There will be occasional Blackboard-based quizzes that all students will be required to complete on their own. These will not be accepted late or excused for any reason. Each assignment will be graded on a scale of 0-20. Students should be prepared for the possibility of an in-class "pop quiz" on every class day, except those dedicated to a review or an exam. These quizzes will generally consist of short answer questions. These, if any are given will also be graded on a 0-20 point scale. At the end of the semester all homework and quiz points will be totaled and included into the final grade based on the percentage of total possible points earned. For example, if we have two Blackboard quizzes, three homework assignments, and two "pop quizzes," then a student's total score on those seven assignments will be divided by 140 to determine a percentage. This percentage will be rounded to the nearest tenth of a point and added to the two exam scores to determine that student's final grade.

There will be two exams (including the final). Each exam will be graded on a 100-point scale. Exams may contain multiple choice, matching, true/false, short answer, and essay questions. For more details, please refer to the Blackboard review for each exam. Review suggestions and sample questions for each exam will be posted prior to each exam.

Grading Plan: Grades for this course will be determined based upon your percentage of total points using the following scale: 90-100% = A, 80-89.99% = B, 70-79.99% = C, 60-69.99% = D, and below 60% = F. There will be 300 total possible points (200 from exams and 100 from all

other assignments), so the points scale will be 270-300 = A, 240-269 = B, 210-239 = C, 180-209 = D, and 0-179 = F. I do not expect to offer any extra credit during this course. Only exam grades will be posted on BlackBoard.

Study Tips: All students are encouraged to attend every scheduled class meeting. In addition, because this class focuses on developing critical thinking skills, students are encouraged to attempt the exercises offered in the <u>Power of Critical Thinking</u> textbook. Often, working together in groups to practice the skills presented is an effective strategy. However, all students are expected to complete all homework assignments and quizzes on their own. Students are encouraged to make use of the SAM Center, the Reading Center, and the Writing Center.

For any student caught violating the policy on academic dishonesty, I will enter a grade of 0 for the given assignment and work with the appropriate university authorities to seek the expulsion of the student. In all cases, I will seek the maximum penalty allowed by the university.

Instructor Evaluations: Near the end of the semester, all students will be asked to complete an IDEA evaluation of the instructor's performance in this class. This confidential evaluation is your chance to provide feedback on the effectiveness of this course.

Classroom Rules of Conduct:

Students are expected to assist in maintaining a classroom environment that is conducive to learning. Students therefore must refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular phones, pagers, and music players (for example, iPod-type devices) must be turned off and earphones removed before class begins. Students are prohibited from using tobacco products, making offensive remarks, reading newspapers, talking at inappropriate times, or engaging in any other form of distraction.
