# Course Description:

This course is a survey of diseases and conditions of the horse. A larger definition of 'diseases' will be used to include behavioral problems, lameness, etc. Both normal and abnormal conditions will be discussed as well as their common treatments.

# Course Objectives:

The course will provide students with a basic understanding of conditions and diseases common to the horse. This course is not intended to give the student the knowledge to practice veterinary medicine, but rather to give the student a *basic* lay understanding of *common* diseases and conditions involving the horse. It will hopefully encourage the student to pursue acquiring further knowledge of the horse and/or veterinary medicine.
