Course Description: GENERAL PHYSICS – MECHANICS AND HEAT. A modern

treatment is made of the laws and principles of mechanics and heat. Derivations are carefully done using a non-calculus approach and

considerable problem work is required.

Course Objective: This course is to provide the student with a clear and logical

presentation of the basic concepts and principles of physics, and to strengthen an understanding of the concepts and principles through

a broad range of interesting application to the real world.

Required Textbook: College Physics, Seventh Edition by Serway and Faughn

Required Supplies: Pencils, Pens, Paper and a calculator that has the trigonometric

functions.

Optional Texts: None

Attendance Policy: In compliance with Federal regulations, attendance will be

taken at every class by means of a sign-in sheet. The student will be required to sign the sheet. Failure to do so will result in the student being considered absent for the class. Federal regulations, and University policy, require that the instructor

reports the last day of attendance any time that a student drops or withdraws from class.

Class will start and end at the assigned times. No one will be permitted to enter the classroom after class has started. Please see the university catalogue for institution expectation regarding class attendance.

No make-up exams will be given unless written justification from a physician is provided. Make-up exams will be given to students in compliance with the Religious Holy Days policy given below. Attendance is not used to calculate the final course grade.

Assignments: Homework problems will be assigned and some will be turned in

for grading. The purpose of this is to prepare the student for the examinations, which will consist of problems similar to the homework. The average homework grade will have the same

weight as a major examination.

Exams: Four major examinations will be given during the semester and at

the end of the semester, a comprehensive final examination will be

given.

Grading Plan: Homework and major exams will count 75% of your term average

with the final exam yielding 25%.

Academic Dishonesty: All students are expected to engage in all academic pursuits in a

manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating on an examination or other academic work which is to be submitted,

plagiarism, collusion and the abuse of resource materials.

Classroom Rules of Conduct: Students will refrain from behavior in the classroom that

intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins. Students are prohibited from eating in class, using tobacco products, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are

especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

Visitors in the Classroom:

Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether the visitor will be allowed to remain in the classroom.

Course Outline:

Chapters 1 through 12 in the text. This may be altered at the discretion of the instructor.

American Disabilities Act:

Religious Holidays:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
