**DESCRIPTION OF COURSE:**

Spanish 264 is a continuation of Spanish 263 with special emphasis on practical needs for conversation. It will include more practice in reading and composition. Spanish 264 is designed to further expand the student's proficiency in the four basic language skills: listening, speaking, reading, and writing. The prerequisite for enrolling in SPN 264 is the completion of SPN 263 with a grade of C or higher or appropriate scores on the CLEP or AP examinations. The prerequisite for enrolling in upper-division Spanish courses is the completion of SPN 264 with a grade of C or higher or appropriate scores on the CLEP or AP examinations. However, if a graduating senior makes a D in Spanish 264, it will be accepted for graduation purposes.

**STYLE**

This course has two delivery methods: an on-line BLACKBOARD for information outside class meetings and a DISCUSSION STUDENT-CENTERED format in class meetings with a minimum of professor lecture. Since language is a social skill and activity, this is the only way to effectively learn. In speaking, mistakes are natural--tolerance and assistance are important. Be flexible--think of another way to send the same message if you have difficulty expressing yourself.

**GENERAL GOALS**

1. increased **AWARENESS** of and **APPRECIATION** for Hispanic language and culture
2. additional **VOCABULARY** in Spanish to express your ideas
3. ability to **CONJUGATE** verbs so that a native speaker can understand the sentence
4. ability to **CONVERSE** about work, diversions, travel, the arts, family life, news, and television
5. learn to **ADAPT** to unexpected questions or responses

**COURSE OBJECTIVES**

1. To **LISTEN** to and comprehend standard Spanish spoken at average native speed
2. To **SPEAK** without notes (or read aloud) standard Spanish with few enough pronunciation errors to be comprehended by a native speaker

3. To **READ** and comprehend selected Spanish readings
4. To **WRITE** standard Spanish with few enough grammar errors to be comprehended by a native speaker
