Course Title: Software Forensic Evidence Mgt

Course Description

Analysis of investigative techniques and tools in the detection, investigation and analysis of digital crimes. This course examines the nature of cyberevidence and the tracking and identification of cybercriminals. There will be an emphasis on current and emerging issues in the field.

3. Be able to select and manage forensic software in a digital environment.

Attendance Requirements

Each student will be required to post for each reading assignment comments and critiques on the subject matter just read. Comments and discussion are required from other students. Do NOT repeat back a synopsis of the reading assignment. Comments and discussion are to be based on original thoughts. Every Friday each student is to critique the thoughts and comments of the other students on the roster. Each classmate is to be rated from highest to lowest. DO NOT post the critique to Blackboard. Email this critique directly to me by midnight each Friday. Your grade will be based on critiques by classmates and instructor review. No harassment or profanity will be allowed. Please treat each and every classmate with respect.

Labs

There will be 3 lab cases assigned. Students may complete the lab work in the digital forensic labs.

Exams

The course grading system includes three tests and a final examination. Each of the tests will consist of 10 short answer (1 – 2 paragraphs) questions. The final examination will consist of 15 short answer questions. The final will be comprehensive. No make up tests/examinations will be allowed save for documented medical emergencies.

Research/Writing Assignment

The research assignment will consist of a research paper to be written in APA style. There should be no less than 15 references. The research paper will be presented to the class at the end of the semester.

Grading Criteria

Each test will be worth 100 points.

Labs will each be worth 100 points.

The research paper will be worth 100 points.

Discussion participation will be worth 300 points.
