**Course Description:** This course covers products and factoring of polynomials, algebraic fractions, exponents and radicals, quadratic equations, functions and graphs, applications and systems of equations. Each class will be primarily lecture-oriented.

**Course Objectives:** Students will be expected to master most material in chapters 5-8 and some selected material from chapter 9.

**Required Textbook:** *Intermediate Algebra: Concepts and Applications 7<sup>th</sup> Edition*, by Marvin A. Bittinger, David J. Ellenbogen. Pearson Addison-Wesley.

**Required Supplies:** A graphing calculator - TI-83 or TI-84 recommended. Calculators with Computer Algebra Systems such as TI-89 will not be allowed. If you have questions about your calculator, please see me.

**Attendance Policy:** Regular and punctual attendance for this course is mandatory. If class must be missed, the student is expected to get the notes from a classmate, and to check the web-page for announcements and updated assignments. For all documented and university-approved absences (e.g. hospitalization, court appearances, university athletic conferences, etc...) students must immediately contact and inform the instructor of the situation and present proper documentation upon re-entering the classroom.

Students are expected to arrive to class on time. If a student is perpetually late, they will be asked not to attend class unless they arrive on time. If tardiness becomes

a problem for the class as a whole, people who arrive late will not be permitted to enter the class. If this stricter policy becomes necessary, there will be an announcement made in class and posted on the web-page.

**Assignments:**

1. **Homework:** Homework will be assigned in class each day. Homework will not be collected, but students are encouraged to check their work with the solutions manual. Assignments can be found online.

It is your responsibility to ask questions about homework problems which you were not able to complete or did not understand. It is your responsibility to come to office hours, or otherwise contact someone for help. It is also your responsibility to do as many problems from each section as you need to in order to feel comfortable with the material.

2. **Quizzes:** There will be daily short quizzes, consisting of questions from the homework or the previous day's lecture.
3. **Participation:** At the beginning of class each day, students will be expected to present a homework problem to the class. Each student should have several problems prepared each day, and will be asked to write a complete solution on the chalkboard. Grades will be assigned based on the number (and frequency) of problems presented, as well as the completeness of the solutions.

**Exams:** There will be a midterm and a final exam. They are tentatively scheduled to occur on:

Midterm Exam: Wednesday, 18 June
Final Exam: Tuesday, 1 July

Any changes to this schedule will be announced in class and posted on the web-page. There will be no makeup exams, except for official University-sponsored activities.

**Grading Plan:** The course grade is based on:

**Academic Dishonesty:** All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. **Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action.** The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, collusion and the abuse of resource materials.

**Classroom Rules of Conduct:** Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins. Students are prohibited from using tobacco products in class, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

**Visitors in the Classroom:** Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.

**Student Absences on Religious Holy Days Policy:** Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a

student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable time frame in which the missed assignments and/or examinations are to be completed.
