Supervise graduate students in psychology or counseling programs. This is advanced professional work which may require the development of new or improved techniques and procedures with some latitude for independent action and decision. Performs other related duties as assigned.

OTHER SPECIFICATIONS: Demonstrated commitment and competency to work in a university counseling center environment with a broad range of students, including first generation college students and those students coming from traditionally underserved populations.

This is a post doctoral or pre-LPC (Licensed Professional Counselor) internship position, generally lasting one to two years, contingent upon funding. The incumbent will receive appropriate supervision towards fulfillment of post degree hours needed for licensure.
