COURSE OBJECTIVES:

This course is intended to provide the student with an understanding of Computer-Aided Drafting principles. Students will utilize the software command structure of the most predominately used 2D CAD program, namely AutoCAD (**ACAD**), to complete a number of typical and practical drafting application exercises.

COURSE FORMAT:

This course will be a combination of lecture, demonstrations, student inquiry, and in-class problem solving. Each student will be expected to demonstrate the correct use of AutoCAD commands. The students will be required to complete a series of drawing exercises/projects and/or tests that will reflect their knowledge of the stated objectives.

- Must be turned in on Week #15 and picked up during Final Exam time in week #16 or it will be thrown away or kept by our offices as example for future students. HIGHLY advised you get it as at end of your education and courses a Final Portfolio may be required and this is a part of it.

PRESENTATION:

- 2-5 minutes in length
- Demonstrate and explain to class how to do your favorite function, skill, etc.. using ACAD and data projector and/or presenter.
- Explain not only how to do it but why it is your favorite.

ATTENDANCE POLICY:

1. Every student is expected to be present and **on time** for every class. You are tardy whether you come in late or leave early. Roll will take at the beginning of each class or lab session; if you are not in your seat and have completed the evenings Quick Quiz or test, you will be counted tardy (three tardies will be counted as one absent). If you are late and miss the 4:30-5:20pm time frame for Quick Quiz, then you have missed those 20 points possible. **Accumulate six (6) hours and your grade will drop by a letter, nine (9) hours and it drops by two (2) letters.** Attendance will be taken based upon Quick Quiz and turned in work for the evening. In case you are absent, whether excused or unexcused, you are still responsible for the material covered.

NOTE: I take roll based upon turned in practical assignments for that night. So even if you don't complete all assignments, make sure you have completed and turned at least one of them. Class will end when you are done with the assignments and have turned them, or at 9:00pm whichever comes first.

Material and instructions will be disseminated one time only. If you are absent or late, the responsibility for obtaining handouts and information is incumbent on you. These will also be posted on Blackboard the day they are assigned. You would be wise to establish relationships with fellow students for assuring that you remain well informed and that you are adequately prepared for exams.

2. Each student should be prepared for class/lab by having carefully read and studied all assigned textbook readings and/or handouts. Each project is to be done on an individual basis. You should expect to spend **a minimum of three to four hours per week** in lab. Drawings / Assignments turned in late will be penalized ten points per day late. **Work will NOT be accepted for credit beyond one week of the due date.** Absences do not exempt you from the responsibility of turning material in on time and they do not extend the due date of the assignment schedule.
3. There will not be repeat exams, quizzes, or makeup assignments except for extenuating circumstances (Documented illness, family crisis, etc.) or by mutual agreement prior to the absences between the instructor and the student.
4. If you have perfect attendance during this course you will have the option to be exempt from taking the final exam if you have earned enough **POINTS** to receive an A or B. (Documented and approved by instructor absences will not count against you.)

ASSIGNMENTS:

See the calendar provided listing tentative assignments and due dates (also located on Blackboard). All grades are posted on BB, it is YOUR responsibility to keep track of your points. If a grade is missing on BB you must let the teacher know immediately. Show the instructor the graded work so that it can be corrected.

GRADING:

1. **Unit Exams** - 4 Major exams will be given during the semester, 2-Regular Exams on BB; 1-Midterm; and 1 - Final. Tests will consist of written questions over each software application will consist of multiple choice, true false, completion, matching and/or software problem solving and practical timed performance problems using each software.

Lab Assignments/Practical Problems –We will have a total of 10 ACAD assignments worth 100pts each. You will also complete the assignments: History of CAD, Portfolio, and Presentation worth 100 pts each. Each assignment will have a due date and should be completed during your scheduled lab period. Work is due at the beginning of the next class period. Late work will be penalized one letter grade for each day it's late, work more than one week late will receive a zero. There will be 10 assignments worth 100 POINTS combined for that night's assignment.

NOTE: You will submit a paper print out for grading, an electronic copy in the BlackBoard "drop box" to insure academic honesty so that I can do random checks. Additional lab time is available per the open lab schedule posted.

3. **Quick Quizzes – 10** You will have a short quiz (20 minutes maximum) on those weeks when a unit exam is not scheduled. The quiz will consist of 5-20 true-false, matching, or multiple choice questions over current reading and/or lab assignments for that night. There will be no makeup if you miss a quick quiz. Quiz will be available in BB from 4:30-5:20PM for that evening only! Lecture for that night will start at 5:20pm.

GRADING PLAN:

Each lab assignment should be completed during the scheduled lab period. Lab assignments are due at the beginning of the next regular class period. Late work will be penalized 10 points for each day it's late. Work more than one week late will receive a zero.

Each student is expected to individually complete all drawing exercises for each of the units in this course. Penalties will be assessed for work, which is turned in late. Each student will also complete unit tests plus a comprehensive final exam. The final grade for the course will be based upon points earned as follows:

ACADEMIC HONESTY:

If the student repeats the violation, the course grade will be assigned as ‘F’.

CLASSROOM RULES AND CONDUCT:

The lab assistant and instructor will enforce laboratory safety rules for any safety violations. Each safety violation will cause the current lab assignment grade to be dropped by one (1) grade letter for each occurrence. Students who are especially disruptive may be reported to the Dean of Students for disciplinary action in accordance with university policy.
