**COURSE DESCRIPTION**

ENS 501.02 is a graduate level performance class. Student are required to perform at an advanced level of skill and interpretation. There will be at least one performance in the semester associated with this class.

**Prerequisite:** Graduate students; by audition

**COURSE OBJECTIVES**

1. To learn performance techniques appropriate to the major periods of music
2. To rehearse and perform music of high artistic merit
3. To evaluate and analyze music from a performance practice perspective
4. To engage in high level research and performance

**COURSE MATERIALS**

**Required Text:** *The Interpretation of Music*, 3<sup>rd</sup> Edition  
Thurston Dart

**Materials:** Musical instrument (or voice); all of the necessary tuning devices associated with performance. Disks for recording rehearsals and performances.

**ASSIGNMENTS:** students are responsible for completing ALL assignments.

- Due dates/times are not negotiable.

**GRADING – grades will be based upon performance and rehearsal participation.**

**Attitude** – a cooperative, pleasant working relationship in class is appreciated and expected.

**ATTENDANCE:**

**General Information on Attendance:**

1. **Students will not be penalized for two or fewer absences**

2. A student's final grade will be lowered 10 points (one letter grade) for each absence past the 2nd absence
3. A student's final grade will be lowered 1 point for each tardy (Two tardies will be considered as one absence.)
4. A student is counted as being in attendance when:
  - a. The student is physically sitting in his/her assigned seat
  - b. The student has all materials necessary to perform the class activities as required
  - c. The student and the instrument are properly warmed-up (as assigned)
  - d. The student is attentive and ready to participate in class
5. Students are provided a daily sign-up sheet on which to record their attendance. It is the student's responsibility to insure that the sheet is signed.

**Attendance and punctuality are required.**

In any performance-based the final grade is affected subjective judgment by the instructor. Among the most influential factors on a student's grade in class are **ATTITUDE** and **ATTENDANCE**, **PREPARATION** and **PERFORMANCE.** As you surely would assume, these four factors override almost all others. **Cooperation** is expected.

**ACADEMIC HONESTY:**

**PROPER CLASSROOM DEMEANOR/RULES OF CONDUCT**

**Student Absences on Religious Holy Days Policy:** Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the students is excused with a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examination are to be completed.

### **Visitors In The Classroom**

The class will be host to visitors at numerous times during the semester. All courtesies should be extended to visitors at all times. When visitors are present, the class will proceed as usual. Any class member who would like to bring a visitor to class should obtain permission from the instructor prior to that time.

"Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance.
