Catalog Description: This course is an introduction to programming. A software engineering approach to developing computer programs is stressed and object-oriented concepts are introduced. The development of procedures and the writing and testing of programs to implement them is emphasized.

Prerequisite: Basic key-boarding and PC skills.

Methodology: Lecture with outside laboratory assignments. The examinations will cover the material in the lectures, and will require that the student understand, apply, and extend that knowledge.

Objectives: This course will be an introduction to the field of computer science **and** a first course in computer programming. The student in this course will learn how to solve problems with an algorithmic approach and then implement the solutions in a higher level language. The language for this course will be Java. We will emphasize the core language, although we will be using an integrated development environment. Along the way, such topics as software engineering, computer literacy and architecture, structured programming, networking, and operating systems will be addressed in a manner appropriate to the level of the course.

Grading: There will be 3 major tests during the course of the semester. Each will count as 20% of the grade. The final will count as 20% of your grade. There will be several homework and lab assignments which will count as 20% of the grade. The following grade scale is used:
