7. **Course Description:** Topics include limits and continuity, the derivative, techniques for differentiation of algebraic, logarithmic, exponential, and trigonometric functions, applications of the derivative and antidifferentiation.
Prerequisite: MTH 163 or high school equivalent (Trigonometry/Pre-Calculus).
8. **Course Objectives:** Students will be expected to master material in the following sections of the text:
Chapter 1: Functions
Chapter 2: Limits and Continuity
Chapter 3: Differentiation
Chapter 4: Applications of Derivatives
Chapter 5: Integration
9. **Required Textbook:** Finney, Weir, and Giordano. Thomas' Calculus (Early Transcendentals). Eleventh Edition.
10. **Attendance Policy:** You are expected to be in class on time every day. If you miss class for any reason, it is your responsibility to get the notes and assignments from that class meeting. A sign-up sheet will be passed around each class period to monitor attendance.
11. **Assignments:** Homework will be assigned daily to direct you in your studies. This homework is for exposure and practice and will be ungraded. It will be to your advantage to do all of the homework and to do it as soon after class as possible. You are strongly encouraged to work with other students on your homework.
There will also be weekly graded homework which will be collected each Monday. No late homework will be accepted.
Under some circumstances, additional assignments and quizzes may be necessary to facilitate communication and learning. When this happens, the additional grades will become part of the exam grade for the current chapter.
12. **Exams:** At least four exams will be given during the semester, each covering (roughly) one chapter of material. There will also be a cumulative final exam at the end of the semester during the regularly scheduled exam time for this course.
There generally will be no make-ups for missed exams other than for University approved reasons. In most cases, I must be notified of the reason prior to the exam. Make-up exams should be taken as soon as possible after the regularly scheduled exam.

13. **Grading Plan:** At the end of the semester, your grades will be averaged according to: Final exam 25%, regular exams 16% each, homework 11%. Letter grades will be assigned according to:

14. **Academic Dishonesty:** All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, collusion and the abuse of resource materials.
15. **Classroom Rules of Conduct:** Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins. Students are prohibited from eating in class, using tobacco products, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.
16. **Visitors in the Classroom:** Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.
