ATTENDANCE: Attendance will be taken for each class. You have three “free” absences in each discipline (Track and Field, Baseball) after which two points will be deducted from your final grade in each discipline (Track and Field, Baseball) for each absence. There are no “excused” absences. However, an absence can be made up by submitting a typed paper (two pages, double spaced, 12 type size) on a related subject which **must be approved by the instructor of the class that was missed before you write the paper. The report must be submitted to that instructor within two weeks of the absence.**

Class will begin promptly. Credit for attendance will not be given after 9:35 am.

BONUS POINTS: Six points will be added to the student’s final grade (including baseball and track and field) if the student has no absences for the entire semester; four points for one absence; two points for two absences. Other extra credit opportunities may exist and will be assigned as necessary by the instructors.

CLASS STRUCTURE: The first half of the semester will be devoted to the Baseball portion of the class. This will begin on Thursday, August 25 and continue through Tuesday, October 9. The Track and Field portion of the class will begin on Thursday, October 11 and will continue thru Thursday, December 6.
