**Course Description:**

Topics include a review of introductory algebra, equations, relations, functions, graphs, linear programming, systems of equations and matrices, and mathematics of finance. Prerequisites: Two years of high school algebra and one year of high school geometry.

Material will be presented in lectures, Suggested homework will be assigned on a daily basis; this homework will not be collected or graded. These assignments are meant to guide you in learning the material. Homework questions will be discussed at the beginning of each period. Questions regarding the homework are an integral part of the learning experience. They are welcome and anticipated. Most test questions will be very similar to homework problems.

**Course Objectives:**

The objective of this course is to provide business and economics students with the background in the quantitative techniques necessary for understanding and appreciating many of the topics in business curricula. It also lays the foundation for more advanced courses in statistics and operations research.

### Academic Dishonesty

All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. ### Classroom Rules of Conduct

Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. **Cellular telephones and pagers must be turned off before class begins.** Students are prohibited from eating in class, using tobacco products, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engaging in any other form of distraction. I also consider it disrespectful to wear any form of cover on your head, unless it is for religious purposes. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

### Visitors in the Classroom

Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom. This policy is not intended to discourage the occasional visiting of classes by responsible persons. Obviously, however, the visiting of a particular class should be occasional and not regular, and it should in no way constitute interference with registered members of the class or the educational process.
